Circular

Newly elected office bearers of EEFI met at Delhi on 13th September, 2017 to discuss all the matters related to implementation of decisions of the 8th conference. Circulars on Reporting Points of the conference, Yearlong Action Programme, Maha Padav / Parliament March between 9 and 11 November, 2017 has already been issued on 15th September, 2017. Other points discussed and decided in the OB meeting are as under:-


- 1) Allocation of responsibility among the Office Bearers was discussed. In major states like Tamil Nadu, Kerala, West Bengal, Haryana, Punjab we are having more than one Office Bearers. Hence organization in those states will be guided by them collectively, rest of the states will be guided by the leaders as decided :

Specific responsibility on Central Power Sector will be assigned in due course.			

- 2) P Ramamurthy Bhawan is nearing completion. As committed EEFI National Centre will further contribute around Rs. 15 lakhs to cope with the escalated cost of construction. EEFI decided an amount of Rs. 25 per member will be collected from members of our organization to cover the escalated cost and furnishing our national centre with state of art furniture and equipment required for modern office. Only KSEBWA, KSEBOA and Haryana have contributed. COTEE has contributed partially. None of other major organization have sent their contribution. Rs. 8 lakhs is needed by the end of September. EEFI will pay from its fund now. All organisations are requested to remit their contribution to complete our project of setting up EEFI National Centre at Delhi.
- 3) Third Congress of TUI (Energy) will take place at Port of Spain (Trinidad & Tobago) on 7-8 December, 2017. General Secretary, EEFI is Vice-President of TUI (Energy). Besides him two delegates has been allocated. One from KSEBWA and one from Haryana will be EEFI delegate.

- 4) Content of the campaign material for Parliament march (9-11 December) has already been sent to all the states and EEFI leadership. Status of preparation of campaign, number of members participating, journey schedule for the far away states, accommodation at Delhi, preparation of banners, placards along with uniform / apron should be communicated to EEFI centre. Participation of EEFI should be note worthy. Name & contact numbers of the leaders of the delegations should be communicated to EEFI centre well in advance.
