**The 9<sup>th</sup> General Conference of EEFI will take place at Sector 29D, Chandigarh (Com. Shyamal Chakraborty - S. Panchratnam - R C Jagga Nagar) in Bhakna Bhawan (Com N Kiran - K Batabyal - Asit Biswas - V. Laxmanan Manch) Com Nisha Roy - Debabrata Bindu and Other departed leaders will be commemorated in various forms in Gates and Symbols. between 13<sup>th</sup> and 15<sup>th</sup> October, 2022. The inaugural session will commence at 10-30 AM on 13<sup>th</sup> October, 2022 with hoisting of EEFI Flag.**


As per provision of the constitution of EEFI, the delegates of the general conference are elected by the constituent Organisations within the specified criterion. As decided by the Working Committee of EEFI held on 30<sup>th</sup> & 31<sup>st</sup> July, 2022 at New Delhi. Conference will take place with Maximum of 400 delegates on the basis of membership as on 31<sup>st</sup> December, 2021. The Office Bearers of EEFI will be ex-officio delegates. In view of poor attendance of members in the Working Committee meetings, WC members who attended at least two meetings will be conferred right of delegation in Central Quota. Affiliated Union / organisation will elect one delegate par 350 members. A few Observers will be nominated for special organizational reason/s. The general conference will transact the following business:-

- 1) To ratify the decision of deferring the general conference beyond 2 years (as per provision 8i) of the constitution,
- 2) To discuss and adopt the report to be presented by the General Secretary,
- 3) To discuss and adopt the audited statements of Accounts presented by the Treasurer for all the years since 8<sup>th</sup> Conference,
- 4) To adopt resolution on current and forthcoming issues related to interest of working class and electricity industry,
- 5) To discuss any proposal of amendment of any part of the Constitution, (Proposal, if any),
- 6) To adopt programme and the General Policy of EEFI,
- 7) To elect the Office Bearers,
- 8) To elect the Working Committee,
- 9) To raise any other matter with the permission of the Chair.

The delegation of the affiliated unions will be accepted only after payment of all dues payable to the Federation up to 31.12.2021. A Delegate Fee @ Rs. 1000/- par delegate / observer will have to be paid at the Conference venue. All leaders of the delegation should contact the Reception Committee and inform their arrival and departure time well in advance (Preferably by 30th September, 2022) for the mutual convenience.

Conference will continue up to the concluding session before Lunch on 15<sup>th</sup> October, All are to book their up and return journey keeping in view the schedule detailed above.
