

## Circular

An extended meeting of EEFI Office Bearers took place in BTR Bhawan, New Delhi on 12<sup>th</sup> June, 2022. Com. KO Habeeb presided over the meeting. Agenda of the meeting was placed by the General Secretary through a brief note. Each and every items were explained by the General Secretary and placed for opinion of the members present. The decisions arrived upon are appended below for information & needful steps for implementation by the organisations affiliated to and associated with EEFI. Com. Swadesh Dev Roye, Working President reported on 18<sup>th</sup> World TU Congress with stress upon salient features of the Rome declaration. In the course of deliberation he embraced the world as well National crisis posed by the game plan of Capitalist - Imperialist and Communal forces. Issues related to Energy Transition and impact upon Working Class as well Indian people kept for detailed discussion in the Brain Storming Session to take place on 13th June under the joint initiative of All Indian Coal Workers Federation, EEFI and Petroleum & Gas Workers' Federation of India. Participation by five EEFI leaders has been decided.

- 1. Apropos discussion in Chennai Working Committee meeting invitation of All Haryana Power Corporation Workers' Union for hosting the 9<sup>th</sup> EEFI National Conference in Haryana is accepted. Venue has been decided in Chandigarh, Dates for the Conference has been decided from 15<sup>th</sup> to 17<sup>th</sup> October, 2022. Total Nos. of delegates including EEFI Office Bearers will be limited to 400. The affiliated organisations are to clear all their affiliation dues by 30<sup>th</sup> July.
- 2. Basis of delegation will be arrived upon the deposited affiliation based upon the return submitted for the year 2021. All are to deposit affiliation dues on or before 30<sup>th</sup> July, so that number of delegates for each union/ organisation be prepared and decided on 31<sup>st</sup> July. In respect of fraternal delegation, decision will be arrived upon in due course. States having no electricity TU affiliated to EEFI but functioning organisation ideologically closer to us may be invited to take part as 'observer' limited to one each.
- 3. Next meeting of the Working Committee will take place in Delhi on 30 & 31 July 2022. Details for the Conference including delegation will be decided in this meeting of the Working Committee. Working Committee will issue the guidelines to the affiliated organisation relating to proportioned delegate covering all sections of workers and employees. Affiliation Dues List as per EEFI centre record is annexed hereto.
- 4. It has been decided that Draft Report of the General Secretary will be developed through collective effort. Members of OB team volunteered to write on the topic wise sections and sub-sections as mentioned in the Annexed sheet. Report for the Union / state for the period since 8<sup>th</sup> EEFI conference will be prepared by the union / state concerned.

5. Registration of EEFI within the ambit of TU Act, will be complied from Kerala. Com K. Jay Prakash and Com S. Harilal has been assigned the responsibility. This meeting decided, if any minor modification of EEFI constitution is necessary to match with laws of the land that will be done with approval of the Working Committee subject to final ratification by the 9<sup>th</sup> Conference. Hence, this meeting needs to resolve that the Registered office of the Federation will be BTR Memorial, Mele Thampanoor, Thiruvananthapuram, Kerala, Pin Code - 695 001

The National capital centre office will be in P. Ramamurty Bhawan, Plot No.20, Pushp Vihar, MB Road, Saket, New Delhi - 110 017. Besides the President and General Secretary, signature of Office Bearers required for the process will be taken up for execution. All formalities will be completed before the next meeting of the Working Committee to take place in Delhi.

6. EEFI will host the next meeting of the Executive Committee of TUI(C&E) in India. COTEE has come forward to shoulder the responsibility. The venue will be Chennai. Date as proposed to TUI(C&E) Centre, Paris will be 22<sup>nd</sup> November, 2022. Total days of activities including arrival and departure will be three. In the Evening of 22<sup>nd</sup> November, there will be assembly of Energy Workers, to be addressed by national and international leaders.
