CIRCULAR

Members of NCCOEEE National Chapter met over Google Meet on 2nd May, 2020 to discuss the situation after a fortnight since Notification of Ministry of Power, Govt. of India. Shri Shailendra Dubey presided over the meeting. Period extended for public comment has been extended up to 5th June. All the members expressed their agony over astonishing hurry of the Government in the ambience of nationwide lock down. Prime Minister has given consent to go ahead keeping priority over struggle of India against COVID-19. In this juncture NCCOEEE discussed all aspects to launch protest movement involving wider section of people and their organizations. All NCCOEEE constituents are requested to gear up their respective structural pyramid both vertically and horizontally to rise to the situation.

- All central trade unions and peasants organizations are to be apprised of the salient points of the draft Electricity (Amendment) Bill, 2020 detrimental to end consumers. They will be requested to send Memorandum to the Prime Minister. Trade Union leaders in NCCOEEE will take needful initiative expediently.
- All National Federations and NCCOEEE will send letter to all Chief Ministers & MPs to take the initiative to drop enactment of the draft Electricity (Amendment) Bill, 2020 par e-mail. Draft of the letter will be circulated among the NCCOEEE leaders by Monday, 4th May. Suggestion of any addition/ alteration should reach to convener by Tuesday, 5th May.
- All NCCOEEE state chapters will meet online before 10th May to plan massive mobilization before Power utility offices / Projects / Stations on compliance health protocol.
- Meeting assigned the responsibility of drafting the memorandum by next week end. The draft will be circulated among the members of NCCOEEE national chapter. Any addition/alteration should be sent back by two days next. Besides NCCOEEE memorandum, all National Federation may submit individual memorandum in line with the broad framework of NCCOEEE.
- National Protest Day will be observed after lock down period through wearing Black Badges and mobilization both centralized and decentralized as widest as possible. Convener will discuss over phone with all the members of NCCOEEE national chapter to decide the date. Campaign material like leaflet, Electronic Poster and audiovisual presentation will be developed for circulation by the earliest possible time. Target audience of these campaigns will be electricity consumers and people of all walks of life besides members of family, friends and acquaintances of electricity employees.
